NOTE: We highly recommend the SIA Door Supervisor licence course over an SIA Security Guarding licence course. Whilst a licensed door supervisor can act as a security guard, a security guard, even with the required license, cannot take the place of a door supervisor.

Obtaining the Level 2 Door Supervisor qualification is the first step towards getting an SIA License to work in the security industry. If you are looking to work in the Security industry as a Security Guard or a Door Supervisor, this is the right course for you.
